2. The learned Additional Public Prosecutor would submit that on the basis of the representation made by the petitioner, enquiry was

undertaken in CSR No.852 of 2023. During the course of enquiry, both sides appeared and the private respondents gave a statement that they will not make any trouble to the petitioner and her husband also. Further, the private respondents were advised not to make any trouble to the petitioner and her family members.

3. In view of the above said development, nothing survives for further consideration or direction in this matter. If any trouble arises in future, at the hands of the private respondents, the petitioner can very well maintain a proper petition before the competent authority.

4. With this direction, this Writ Petition is disposed of. No costs.
