2. The learned Additional Public Prosecutor would submit that on the basis of the complaint given by the fifth respondent, enquiry was undertaken in C.No.163 of 2023. During the course of enquiry, finding that it is a civil issue between the parties, it was closed on 21.12.2023, advising the parties to workout their remedy through appropriate civil process.

3. Recording the submissions made by the learned Additional Public Prosecutor, nothing survives for further consideration or direction in this matter. Hence, this matter has become infructuous.
