ORDER

The present writ petition has been filed by a Conductor of the respondent Transport Corporation who attained superannuation on 31.05.2023 seeking to quash the order passed by the authorities wherein they have sought further time for disbursing the terminal benefits.

2. A perusal of the impugned order, dated 13.12.2023 reveals that due to paucity of funds, they are not in a position to release the terminal benefits. According to the learned counsel appearing for the petitioner, terminal benefits have not been released so far.

3. Considering the above said facts, there shall be a direction to the respondents herein to release gratuity and PF on or before **31.03.2024**. The other terminal benefits shall be released on or before **31.07.2024**.
