PRAYER : Writ Petition filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Mandamus, directing the respondents to settle the petitioner's retirement benefits including gratuity, commutation of pension, arrears of monthly pension from 31.01.2015 till the date of realization of amount as per the settlement, dated 13.04.2015 under section 12(3) of ID Act 1947 w.e.f. 01.09.2013, payable to him with 18% rate of interest within the time that may be stipulated by this Court.

ORDER

The present writ petition has been filed by a Conductor of the respondent Transport Corporation who had retired from service on 31.01.2015.

2. According to the learned counsel appearing for the petitioner, after the retirement of the petitioner, the trade union and the management have entered into a settlement under Section 12(3) of the Industrial Dispute Act. As per the said settlement, monetary benefits would be disbursed from 01.09.2013 onwards. Seeking the said benefits, the petitioner has given a representation on 26.09.2023. Since the said representation has not been considered, the present writ petition.

3. Considering the above said facts, the respondents herein are directed to confer the eligible benefits upon the writ petitioner within a period of twelve (12) weeks from the date of receipt of copy of this order.
