ORDER:

Crime No.96 of 2019, dated 26.02.2019 was registered with Shamirpet Police Station, Cyberabad District for the offences punishable under Sections 406, 409, 420 of Indian Penal Code, 1860 (I.P.C.). The charge sheet was filed in the month of September, 2019 and the same is numbered as CC. No.1574 of 2019 on the file of the learned XXI Metropolitan Magistrate Court at Medchal, Cyberabad. The present petition is filed in the year 2020.

pending shall stand closed.

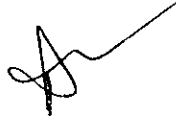

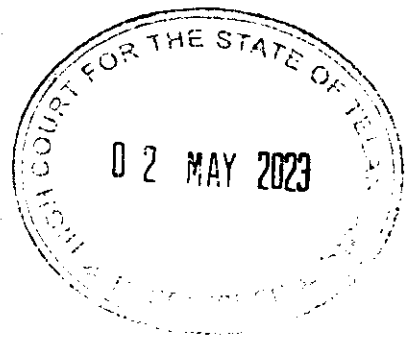
