ORDER:

When the matter is taken up for hearing, Sri R.R.Kalyan, learned counsel for the petitioner fairly submits that during pendency of the present contempt case, the petitioner filed fresh W.P.No.4252 of 2022 questioning the action of the respondents that they have not paid compensation strictly in view of the principle laid down by the Apex Court in **Land Acquisition Officer-cum-Revenue Divisional Officer, Chevella Division, Domalaguda, Hyderabad v. Mekala Pandu¹** and the said writ petition is pending.

2. In view of the said submission, no further adjudication is required in the present contempt case.

3. Accordingly, the Contempt Case is closed. However, the petitioner is granted liberty to agitate all the grounds which are available in law in the pending writ petition. No costs.
