Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, order or direction more particularly one in the nature of WRIT OF MANDAMUS, declaring the action of the respondent authorities in not considering the representation submitted by the petitioner on 30/12/2022 for taking action against the 4th Respondent making illegal construction on the common passage which is using for public purpose in respect of the house property bearing no. 23-3-563 admeasuring 48.22 sq yards situated at Sultan Shahi, Hyderabad, Telangana State is illegal, arbitrary, unconstitutional, contrary to law and violation of principals of natural justice and consequently direct the Respondent authorities to consider the representation submitted by the petitioner on 30/12/2022 and take action against the 4th Respondent with regard to illegal construction;
