Petition Under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue Writ Order or Direction more particularly one in the nature of WRIT OF MANDAMUS, to declare the inaction on the part of the 3rd respondent in not incorporating the name of the petitioner in the concerned revenue records and not issuing the pattedar pass book and title deeds in respect of the land admeasuring Ac. 5.00 in Sy.No.514/2 of Jeelacheruvu Village, Kusumanchi Mandal, Khammam District inspite of the letter L.Dios.No.A1/1502/09 dated 25-7-2009 addressed by the 2nd respondent, as being arbitrary and illegal and consequently direct the respondents to incorporate the name of the petitioner in the concerned revenue records and to issue the pattedar pass book and title deeds in pursuance o the representation dated 25-8-2009.

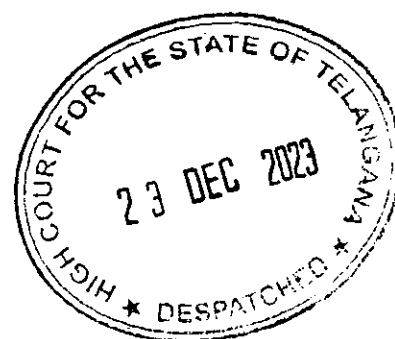
