Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to Issue a Writ, Order or Direction more particularly one in the nature of Writ of Mandamus, declaring the action of the respondents 2 to 4 in failing to take steps for conducting actual survey of land in Sy No. 403 to an extent of Ac.5.17 gts in Block No.B, Ward No.10 situated at Shaikpet Village and Mandal, Hyderabad District in terms of the Order of the 10 respondent Memo No. 2049/SS.I/2014-1, dated 31.01.2014 and-the consequential proceedings of the 2nd respondent in Rc No. N2/414/2014 dt. 19.02.2014 as illegal, arbitrary, unconstitutional and consequently direct the respondents to conduct actual survey on Sy No. 403 to an extent of Ac.5.17 gts in Block No.B, Ward No.10 situated at Shaikpet Village and Mandal, Hyderabad District in terms of Land Tippans and Town Survey Register and to submit the actual survey report to the 2nd

respondent to enable the 1st respondent to pass orders on the Revision petition pending before it dt. 03.01.2014.

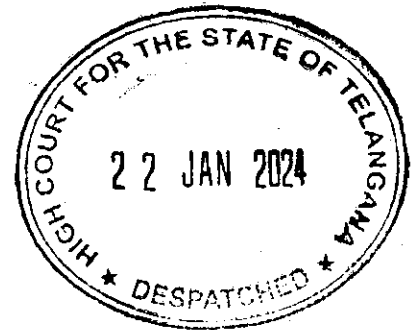
