Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ, order or direction more particularly one in the nature of writ of mandamus or any other appropriate writ.(V)declare that the petitioner is eligible for appointment to the post of SCT Police Constable (AR) in pursuance to Notification Rc.No.151/Rect./Admn.1/2015 dated 31.12.2015 in terms of S.C.No. 278 of 2013 dated 19.02.2015 on the file of I Assistant Sessions Judge, Warangal (vi) declare the proceedings vide C.No.4001/A2-PC/Recd./2017, C.O.No.1604/2017, dated 30.08.2017 as illegal, arbitrary and violative of principles of natural justice (vii) and consequently set aside the same and direct the Respondents to consider the case of the Petitioner for appointment to the post of SCT Police Constable (AR) by duly taking into consideration of the judgment in S.C.No. 278 of 2013 dated 19.02.2015 on the file of I Assistant Sessions Judge, Warangal.
