The Court made the following: ORDER

CRIMINAL PETITION No.673 OF 2020

O R D E R:

This Criminal Petition is filed under Section 482 of the Code of Criminal Procedure, 1973 (for short 'Cr.P.C.') by the petitioner questioning the order dated 25.09.2018 passed in CrI.M.P.No.478 of 2018 in CrI.A.No.835 of 2018 by the V Additional District and Sessions Judge, Ranga Reddy District at L.B.Nagar, whereby the learned Sessions Judge suspended the sentence passed in C.C.No.131/2017 on the condition that the petitioner shall surrender before the trial Court within ten days from the date of the order i.e. 25.09.2018 by furnishing two sureties of Rs.10,000/-each and also deposit 5% of the cheque amount.

2. The case is coming up for hearing after three years and there are no interim orders which are granted by this Court in this petition.

3. Since the petition is filed questioning the suspension order which was passed nearly five years ago, I do not find any reason to keep this petition pending.

4. Accordingly, the Criminal Petition is dismissed.
