Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ Order or Orders, more particularly in the nature of Writ of Mandamus declare the impugned Proc.No.ES/SC/RANG/SEAAS/0070 dt.06/01/2022 issued by the 1st respondent posting the petitioner at Z.P.H.S. Mamidipally of Nandigama Mandal while posting juniors or less meritorious in the places opted by her though her spouse is working as Gr.I Hostel Welfare Officer by overlooking her merit and seniority in the cadre of School Assistant even while including the candidate who came on inter-district in the year 2005 have been placed above me and posted is clearly illegal, arbitrary, unjust and set aside the same, and consequently hold that the petitioner is entitled to be posted in her

opted places including existing vacancies nearer to her spouse with all consequential benefits.
