Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, order or direction more particularly one in the nature of Writ of Mandamus declaring the action of the Respondents in not receiving the application form and not releasing the power supply to the petitioner House Bearing Plot No.181, admeasuring 300 sq yards in sy.No.11/19, Situated at Khanamet Village, Serilingampally Mandal, Ranga Reddy District as illegal, null, void, arbitrary and consequently direct the respondents to release the power supply without being influenced by the instructions of the 5th respondent;

ORDER:

Heard learned counsel for the petitioner, Mr.R.Vinod Reddy, learned Standing Counsel for TSSPDCL, appearing for respondents No.1 to 4 and Mr.M.A.K.Mukheed, learned Standing Counsel for GHMC appearing for respondent No.5. With their consent, the writ petition is disposed of at the stage of admission itself.

2. When the matter is taken up for hearing, it is submitted by the learned counsel for petitioner that the issue raised in the present writ petition is squarely covered by the orders passed by this Court in W.P. No.22849 of 2018 dated 05.07.2018, W.P.No.21100 of 2019 dated 25.09.2019 and W.P. No.7997 of 2020 dated 11.06.2020.

3. The above said submission is not disputed by the learned Standing Counsels appearing for the respondents herein.

4. In view of the same, for the reasons alike in the orders referred to above, this writ petition is disposed of directing the respondents to release individual service connection to the petitioner's property within a period of four (04) weeks from the date of receipt of a copy of this order, subject to the petitioner fulfilling other formalities and conditions stipulated by TSSPDCL. The service connection so given

shall be subject to further directions that may be issued by the State of Telangana or the Apex Court in the litigation pending before it arising out of the order dated 12.09.2012 in W.P.No.20407 of 2008 and batch. There shall be no order as to costs.

Miscellaneous applications, if any pending, shall also stand closed.
