This Criminal Petition is filed under Section 482 of the Code of Criminal Procedure, 1973 (for short 'Cr.P.C.') by the petitioner-Accused No.1 to quash the proceedings against him in C.C. No.378 of 2015 pending on the file of XIII Additional Chief Metropolitan Magistrate at Hyderabad, registered for the offences punishable under Sections 498 A and 406 of the Indian Penal Code (for short "IPC") and Sections 3 and 4 of the Dowry Prohibition Act (for short D.P.
