Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue writ order or direction more particularly one in the nature of writ of Mandamus declaring the action of the respondents in proposing to allot the land in Sy.Nos. 304 and 305 of Desaipet Village admeasuring 6,866 sq. yds belonging to the patta land of the petitioner under the guise of the allotment of land to the illegal, occupants in Sy.No. 300 of Desaipet Village Showing the lands of the petitioners as that of the Government land in Sy.No. 308 as illegal, arbitrary unjust and violative of principles of natural justice and consequently direct the respondents not to allot the plots in the land Sy.Nos. 304 and 305 of Desaipet Village admeasuring 6,866 sq. yds owned and possessed by the petitioners bounded on North - Public way to Desaipet and factory of Abdul Qayyum and others, South- Land of Gandra Malleshham, East-Public Way and West- Land of Syed Mustafa and others to any third parties.

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the respondents not to allot assign, interfere in any manner with the peaceful possession and enjoyment of the land of the petitioners in Sy.Nos. 304 and 305 of Desaipet Village admeasuring 6,866 sq. yds owned and possessed by the petitioners bounded on North : Public way to Desaipet and factory of Abdul Qayyum and others, South: Land of Gandra Mallesham, East: Public Way and West: Land of Syed Mustafa and others to any third parties, pending disposal of the above writ petition.
