Petition Under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, Order or Direction more particularly one in the nature of Writ of Mandamus, declaring the action of the respondents 2 and 3 herein in not taking any action on the building permission application submitted by the petitioner herein 25.10.2014 in respect of Plot No. 415 admeasuring an extent of 226.66 sq. yards in Survey No. 415 beside H No. 8-4-203 situated at Karimnagar Town, Karimnagar District as illegal, arbitrary, null and void and contrary to the various provisions of the Constitution of India as well as the Municipal Corporation Act and for a consequential directions to the respondents 2 and 3 herein to take immediate action on the application submitted by the petitioner for grant of building permission.

415 beside H No. 8-4-203 situated at Karimnagar Town, Karimnagar District, pending disposal of the above writ petition.
