This Criminal Petition is filed under Section 482 of the Code of Criminal Procedure, 1973 (for short 'Cr.P.C.') to quash the proceedings in C.C.No.372 of 2020 pending on the file of Judicial First Class Magistrate, at Metpalli, Jagtial District, registered for the offences under Section 326, 147, 148 read with 149 of Indian Penal Code.

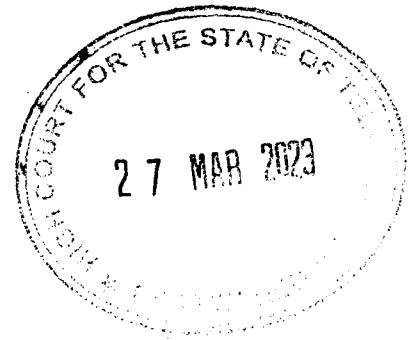
