The present Criminal Petition is filed under Section 482 of Cr.P.C. seeking to direct the Judicial First Class Magistrate at Husnabad, Karimnagar District to receive the returned file vide CrI.P.No.692 of 2014 dated 05.01.2015 in D.V.C.No.9 of 2013.

2. Mr. Ravi Kumar Vadlakonda, learned counsel for the petitioners fairly submits that the subject matter of the criminal petition has become infructuous. Therefore, seeks to dismiss the Criminal Petition as infructuous.

3. Mr. Vizarath Ali, learned Assistant Public Prosecutor appearing for the respondent State takes no objection to the same.

4. Mr. Y. Ashok Raj, learned counsel for the unofficial respondents submits that the D.V.C.No.9 of 2013 filed by the petitioners herein was dismissed by Order dated 12.03.2019 passed by the Court of learned Judicial Magistrate of First Class, at Husnabad.
