ORDER:

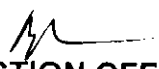

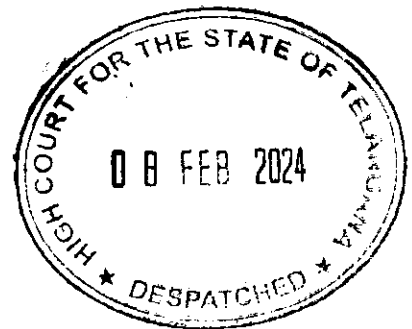
