ORDER:

This Criminal Petition is filed under Section 482 of the Code of Criminal Procedure, 1973 (for short 'Cr.P.C.') by the petitioners/accused Nos.1 to 3 to quash the proceedings in C.C.No.2011 of 2018 on the file of the I Additional Judicial Magistrate of First Class, Warangal. The offences alleged against the petitioners are punishable under Sections 498-A, 448, 506 of Indian Penal Code and Sections 3 and 4 of Dowry Prohibition Act.

2. Heard learned Additional Public Prosecutor for the respondent-State and perused the record.

3. As seen from the proceedings sheet, there was no representation on behalf of the petitioners on 01.12.2023, as such the case was directed to be listed under the caption 'for dismissal'. Today also, there is no representation on behalf of the petitioners, though the case is listed under the caption 'for dismissal'. The status in the trial Court is not known.

4. Accordingly, this Criminal Petition is disposed of granting liberty to the petitioners to approach the trial Court, if cause survives.

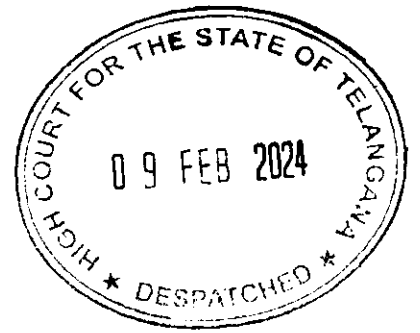
