Aggrieved by the action of the respondents in not allotting the petitioner to Jangaon District and posting the petitioner as School Assistant (PD) on the basis of seniority, the present Writ Petition is filed.

When the matter is taken up for hearing, the learned Government Pleader for School Education appearing on behalf of respondents No.1 to 5 has placed on record a copy of the proceedings *vide* Memo No.Spl/Secretary Peshi/2021-552, dated Nil.07.2022, and submitted that in compliance of the interim order passed by this Court on 22.02.2022, the respondents have disposed of the appeal filed by the petitioner by duly rejecting his case.

3. At this juncture, learned counsel for the petitioner has sought liberty to challenge the proceedings dated Nil.07.2022.

4. In view of the submissions made by the respective counsel, the Writ Petition is disposed of granting liberty to the petitioner to challenge the proceedings dated Nil.07.2022, if he so desires. There shall be no order as to costs.
