Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, order or direction more particularly one in the nature of Writ of Mandamus declaring the impugned Proc.No. ES/SC/AD/KOMA/LAPA/0168, dated 24/12/2021 issued by the 1st respondent as being illegal, arbitrary, unjust and violative of Articles 14, 16 and 21 of the Constitution of India besides being contrary to the guidelines issued by the Government for allocation of employees issued in G.O.Ms.No. 317, dated 6/12/2021 and consequently set-aside the same and hold that the petitioner is entitled for allotment to Adilabad District on spouse grounds and also taking into consideration that juniors to the petitioner were retained in Adilabad District with all consequential and attendant benefits.
