Petition under Section 482 of Cr.P.C praying that in the circumstances stated in the Memorandum of Grounds of Criminal Petition, the High Court may be pleased to quash all further proceedings in C.C.No. 239 of 2012 on the file of X Metropolitan Magistrate, Malkajgiri, Cyberabad, in the interest of justice.

No. 239 of 2012 on the file of X Metropolitan Magistrate, Malkajgiri, Cyberabad, pending disposal of the above Criminal petition.

This Petition coming on for hearing, upon perusing the Memorandum of Grounds of Criminal Petition and upon hearing the arguments of Sri T S ANIRUDH REDDY ,Advocate for the Petitioner and the Public Prosecutor on behalf of the Respondent No.1 and of None appeared for the Respondent No.2.

The Court made the following: ORDER

THE HONOURABLE SRI JUSTICE K.SURENDER**CRIMINAL PETITION No.2531 OF 2023****ORDER:**

This Criminal Petition is filed under Section 482 of the Code of Criminal Procedure, 1973 (for short 'Cr.P.C.') by the petitioner-Accused No.6 to quash the proceedings against him in C.C.No.239 of 2012 pending on the file of X Metropolitan Magistrate, Malakjgiri, Cyberabad, Jangaon, filed for the offences punishable under Sections 468, 471 and 420 of Indian Penal Code.

2. Heard. Perused the record.

3. Since the crime is of the year 2011 and the case is of the year 2012, without going into the facts of the case, this Court deems it appropriate to direct the X Metropolitan Magistrate, Malakjgiri, Cyberabad, Jangaon, to dispose off the said calendar case as expeditiously as possible, within a period of six (06) months, in accordance with law, from the date of receipt of a copy of this order.

4. Further, considering that the petitioner – accused No.6 is a woman aged about 55 years, this Court is inclined to dispense with the attendance of the petitioner – Accused No.6 in C.C.No.239 of

2012 pending on the file of X Metropolitan Magistrate, Malakjiri, Cyberabad, Jangaon, when represented by her counsel on record. The attendance of the petitioner is dispensed with subject to filing an affidavit by the petitioner stating that in her absence the proceedings conducted by her counsel will not be disputed by her in any manner and shall not dispute her identity also. However, the petitioner shall appear before the learned Magistrate as and when her presence is required. In the event of the failure of the petitioner to appear when the Court directs, this order dispensing her attendance shall stand cancelled.

5. With the above observations, the Criminal Petition is disposed off.

Miscellaneous applications pending, if any, shall stand closed.
