Petition Under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue Writ, order or direction particularly one in the nature of Writ of Mandamus or any other writ or direction, to declare the impugned order of 2nd respondent bearing No. 2926FTSEC-PR/Jajireddygudem/GPS/2019 (57) dated 15/12/2020 declaring the petitioner to be ineligible for a period of 3 years from contesting any post and to disqualify to hold the post of elected ward members 4 is illegal, arbitrary, without jurisdiction and violative of Principles of natural justice, though the petitioner submitted election expenditure to the 4th respondent and set aside the same and consequently declare the petitioner is entitled to continue as Ward Member 4 of Kommala Grama Panchayath, Jajireddygudem Mandal, Suryapet District.

Petition Under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the respondent continue the petitioner as Ward Member 4 of Kommala Gram Panchayath, Jajireddygudem Mandal, Suryapet District, by suspending the operation of impugned order of 2nd respondent bearing No. 2926/TSEC-PR/Jajireddygudem/GPS/2019 (57) dated 15/12/2020, pending disposal of the writ petition in the interest of justice.

Heard.

2. This Writ Petition is filed questioning the impugned Order dated 15.12.2020 passed by the respondent No.2 declaring the petitioner as ineligible for a period of three years from the date of order to contest in any elections to be held in any office under Section 23 of Telangana Panchayath Raj Act, 2018 and as per Rule 106 (3) and 106 (7) of the Telangana Panchayath Raj (Conduct of Election) Rule, 2018.

3. As the above said period was elapsed, the cause in the Writ Petition does not survive and the Writ Petition has become infructuous.

4. Accordingly, this Writ Petition is dismissed as infructuous. No order as to costs.

5. As sequel to it, Miscellaneous Petitions pending, if any, shall stand closed.

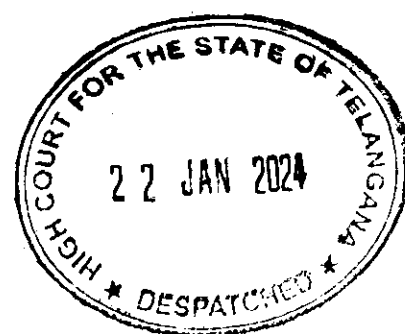
