JUDGMENT:

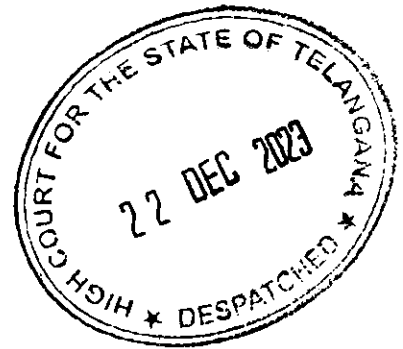
