Petition under Section 482 of Cr.P.C praying that in the circumstances stated in the Memorandum of Grounds of Criminal Petition, the High Court may be pleased to quash the proceedings in Crime No. 191 of 2022, dt.17.12.2022 registered by the Police, Doulothabad for the offences Under Section 306 r/w 34 IPC against the petitioner in the interest of justice.

The Court made the following: ORDER

THE HONOURABLE SRI JUSTICE K.SURENDER**CRIMINAL PETITION No.3036 OF 2023****ORDER:**

This Criminal Petition is filed under Section 482 of the Code of Criminal Procedure, 1973 (for short 'Cr.P.C.') by the petitioner-accused No.3 to quash the proceedings against him in respect of FIR No.191 of 2022 pending on the file of Station House Officer, Doulothabad Police Station, Siddipet District, filed for the offence punishable under Section 306 of Indian Penal Code (for short "IPC").

2. Heard learned counsel for the petitioner – accused and learned Additional Public Prosecutor for the respondent – State. Perused the material on record.

3. The 2nd respondent – *de facto* complainant filed the present complaint stating that his father committed suicide on account of differences with accused Nos.1 and 2. Further, it is alleged in the complaint that on a given day, this petitioner along with accused Nos.1 and 2 armed with sticks trespassed into the house of the deceased.

4. Since there is no specific allegation against this petitioner and keeping in view that the petitioner is a student aged 17 years, this Court deems it appropriate to direct the Investigating Officer in respect of FIR No.191 of 2022 of Doulothabad Police Station, Siddipet District, to conclude investigation without taking any coercive steps against the petitioner – accused. Further, the petitioner – accused shall co-operate with the Investigating Officer as and when required for the purpose of investigation.

5. Accordingly, the Criminal Petition is disposed of.

Miscellaneous applications pending, if any, shall stand closed.
