Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate Writ, Order of direction, preferably one in the nature of Writ of Mandamus and to declare the action of the respondents are not passing final orders on the representation dt.21-2-2022 before the 2nd respondent against orders of the posting dt. 7-1-2022 of the 4th respondent and consequential orders dt. 31/01/2022 of the 4th respondent pursuant to the on spouse grounds in the present cadre as per the G.O.Ms.No.317, G.A. (SPF-1) Department, dt. 6/12/2021, is as highly illegal arbitrary, unreasonable, discriminatory and also in violation of principles of natural justice and also in violation of Art. 14, 16 and 21 of the Constitution of India and declare the same as bad-in-law and consequently direct the respondents to pass final orders on the representation dt.21-2-2022 which is pending before the 2nd respondent

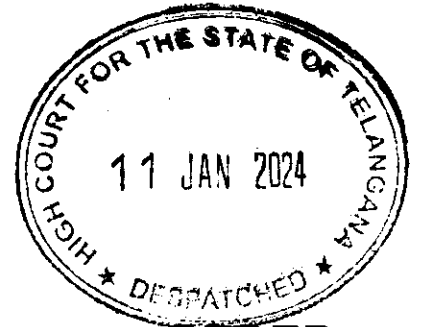
