3. In view of the above said submission, no further adjudication is required. The contempt case is closed. No costs.

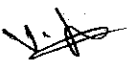

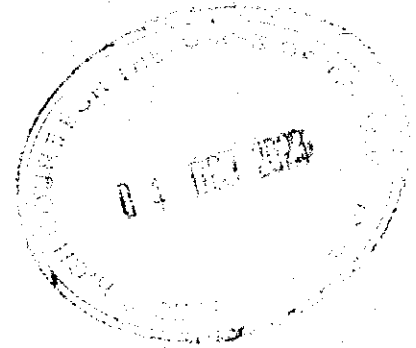
