Petition under Section 482 of Cr.P.C praying that in the circumstances stated in the Memorandum of Grounds of Criminal Petition, the High Court may be pleased to call for the records in connection with FIR No. 38 of 2022 dt. 05/03/2022 on the file of P.S. Kodimial, Jagtial District, registered for the alleged offences U/s. 294(b), 427 r/w 34 IPC and Section 3(2) (va) of the Schedule Castes and Schedule Tribes (Prevention of Atrocities), Act, and QUASH the Same against the Petitioners /Accused No 1 and 2.

ORDER:

This Criminal Petition is filed under Section 482 of the Code of Criminal Procedure, 1973 (for short 'Cr.P.C.') by the petitioners/Accused Nos.1 and 2 seeking to quash the proceedings against them in F.I.R. No.38 of 2022 on the file of Kodimial Police Station, Jagtial District, registered for the offences punishable under Section 294(b), 427 r/w 34 of IPC and Section 3(2) (va) of the Schedule Castes & Schedule Tribes (Prevention of Atrocities) Act.

2. On instructions and as per the e-courts case status proceedings, learned Additional Public Prosecutor would submit that after completion of investigation in the subject crime, the police filed charge sheet before the Court concerned and S.C. Spl.No.274 of 2022 was assigned. Hence, the prayer sought for in the present petition has become infructuous.

3. Recording the aforesaid submission, the Criminal Petition is dismissed as infructuous.
