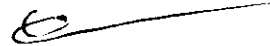
ORDER:

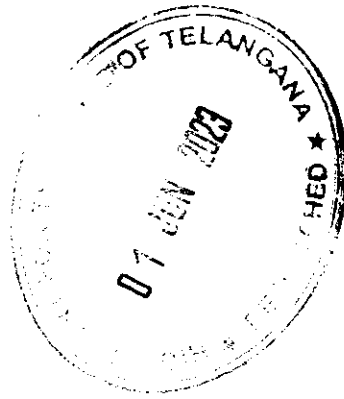
