When the matter has taken up for hearing, on 04.01.2023 and today there is no representation on behalf of the petitioner. However, today the learned Assistant Government Pleader appearing on behalf of the respondents placed Memo No.5680/SCD.Edn/2014-3, Dated 21.11.2014 stating that the petitioner is not eligible for scholarship on the ground that the petitioner has taken spot admission. The candidates who have taken spot admissions are not eligible for scholarship as matter of policy.
