ORDER:

This Criminal Petition under Section 482 of Cr.P.C, is filed by the petitioners-Accused Nos.1 to 3 seeking to set aside the docket order dated 12.04.2019 in CrI.M.P.No.101 of 2019 in C.C.No.611 of 2017 passed by the learned VII Special Magistrate, Hyderabad.

2. As seen from the record, petitioners are aggrieved by the order dated 02.04.2019 in CrI.M.P.No.101 of 2019 in C.C.No.611 of 2017 passed by the learned Magistrate refusing to recall P.W.1 for the purpose of cross-examination.

3. Learned Magistrate passed conditional order dated 02.04.2019 while recalling P.W.1 for cross-examination, on 12.04.2019, the petitioners failed to cross-examine P.W.1, for which reason the application filed for cross-examination of P.W.1 was refused and dismissed.

4. Learned counsel for the petitioners would submit that now the said Special Court has been abolished and it is not

known to which Court the case has been transferred and pending.

5. Accordingly, this Criminal Petition is disposed of. However, petitioners are at liberty to move an application under Section 311 of Cr.P.C, if so advised.

Miscellaneous applications pending, if any, shall stand closed.

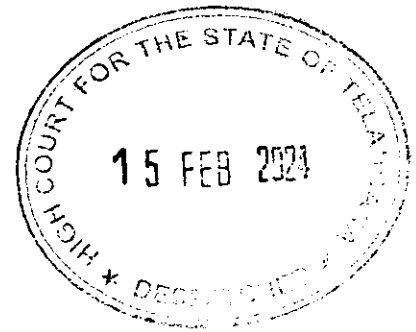
