JUDGMENT:

Plaintiff filed O.S.No.49 of 1994 on the file of Senior Civil Judge, Vikarabad, R.R.District for recovery of money and the same was decreed, against which defendant therein preferred the present Appeal Suit before this Court.

2. A perusal of the docket proceedings shows that the learned counsel for the appellant did not evince any interest to pursue the present appeal proceedings.
