ORDER:

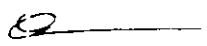
Learned counsel appearing for the petitioner seeks permission to withdraw the Contempt Case and made an endorsement to that effect.

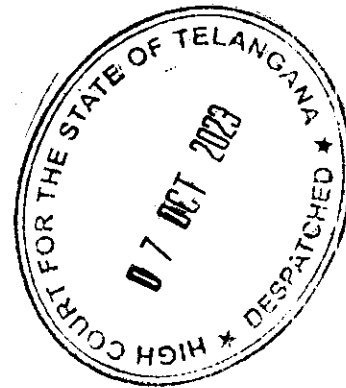
