J U D G M E N T:

This is an Appeal preferred by the Insurance Company aggrieved by the Award dated 27.03.2006 in O.P.No. 1588 of 2004 passed by the X Additional Chief Judge (Fast Track Court), City Civil Courts at Hyderabad.

2. In respect of the very same claim, the Insurance Company filed M.A.C.M.A.No. 250 of 2009 and the claimant filed M.A.C.M.A.No. 2121 of 2006. This Court has dismissed the Appeal filed by the Insurance Company and passed orders in the Appeal of the claimant enhancing the compensation *vide* order dated 06.03.2023.

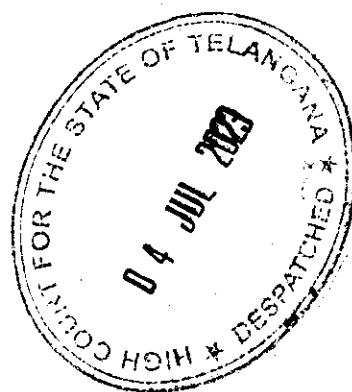
