Petition under Section 482 of Cr.P.C praying that in the circumstances stated in the Memorandum of Grounds of Criminal Petition, the High Court may be pleased to extend the time by 2 more weeks granted in CrI.P.No.6003 of 2023 dated 13/09/2023 to comply the condition stipulated by this Honourable Court for appearance before the investigating Officer in connection with FIR No.366 of 2023 on the file of SHO, Subedari Police Station, Warangal, in the interest of justice.

This Petition coming on for hearing, upon perusing the Memorandum of Grounds of Criminal Petition and upon hearing the arguments of Sri P. SAJAN KUMAR, Advocate for the Petitioner and the SRI S. GANESH, Assistant Public Prosecutor on behalf of the Respondent No.1 and of none appeared for the Respondent No. 2.

The Court made the following: ORDER

This application is filed to extend two more weeks in complying the condition stipulated by this Court vide order dated 13.09.2023 in CrI.P.No.6003 of 2023.

Learned counsel for the petitioner submits that this Court vide order dated 13.09.2023 in CrI.P.No.6003 of 2023 directed the petitioner to appear before the investigating officer on or before 25.09.2023 between 02.00 PM and 04.00 PM in connection with FIR No.366 of 2023. Learned counsel further submits that the petitioner failed to appear before the investigating officer on 25.09.2023 as directed by this Court, as he was implicated in four other crimes and he is apprehending arrest in connection with the said crimes. Therefore, the petitioner seeking extension of two more weeks in complying the condition stipulated by this Court.

Having considered the facts and circumstances, the petitioner - accused No.2 is directed to appear before the Investigating Officer on or before 20.10.2023 between 02.00 PM and 04.00 PM. It is made clear that no further extension will be granted to the petitioner - accused No.2.

The other conditions stipulated in the order dated 13.09.2023 passed by this Court in CrI. Petition No.6003 of 2023 shall remain unaltered.

Accordingly, this IA is ordered.
