Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate Writ, order or direction more particularly one in the nature of Writ of Mandamus declaring the inaction of the respondents particularly Respondent Nos.5 & 6 herein, in conducting necessary survey and demarcation of the land admeasuring 20 Guntas in Survey Number 474/A1 at Etoor village, Nagaram Mandal, Suryapet district, pursuant to the F-Line Application No.DER022300903898 vide Transaction ID.TTDER022300903898, dt.03/04/2023 as illegal, arbitrary, unconstitutional apart from being in violation of principles of natural justice and contrary to the provisions of A.P. Survey and Boundaries Act 1923 and Rules made thereunder, consequently, direct the Respondent Nos.5 & 6, to conduct survey and demarcate the subject land of the Petitioners by fixing up the boundaries thereof.

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the Respondent Nos.5 and 6 immediately to consider the F-Line Application No. DER022300903898 vide Transaction ID.TTDER022300903898, dt.03/04/2023 submitted by the Petitioner for conducting necessary survey and demarcation of the land admeasuring 20 Guntas in Survey Number 474/A1 at etoor village, Nagaram Mandal, Suryapet district, pending disposal of the above writ petition.

The grievance of the petitioner is that respondent Nos.5 and 6 are not acting upon his F-line Application No.DER022300903898, dated 03.04.2023, for conducting survey and demarcation of the land admeasuring Ac.0-20 guntas in Survey No.474/A1 situated at Etoor Village, Nagaram Mandal, Suryapet District.

2. Heard learned counsel for the petitioner and learned Assistant Government Pleader for Revenue appearing for the respondents.

3. Learned Assistant Government Pleader for Revenue submitted that appropriate action will be taken on F-Line application of the petitioner in accordance with law.

4. Recording the above submissions, the writ petition is disposed of directing respondent Nos.5 and 6 to act upon the F-Line application of the petitioner *vide* Application No. DER022300903898, dated 03.04.2023, for conducting survey and demarcation of the land admeasuring Ac.0-20 guntas in Survey No.474/A1 situated at Etoor Village, Nagaram Mandal, Suryapet District, by issuing notice to all concerned/ interested persons, in accordance with law, within a period

of 45 days from the date of receipt of a copy of this order. No order as to costs.

As a sequel thereto, miscellaneous applications, if any, pending in the writ petition stand closed.

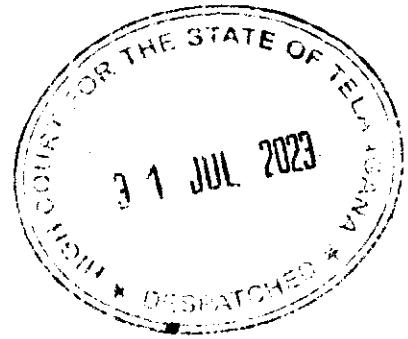
