This Criminal Petition is filed by the petitioner to quash the FIR Cr.No.168 of 2017 on the file of Shamirpet P.S. Ranga Reddy District against the petitioner / accused.

2. When the matter is taken up for hearing today, none has appeared for the petitioner / accused. Perused the record.

3. A perusal of the record would reveal that CrI.M.P.Nos.5461 and 5462 of 2017 are filed for compounding the offences, however both the MPs are dismissed by this Court on 23.08.2017. No interim orders were granted by this Court stalling the investigation. The stage of the investigation is not known. Therefore, I find no reason to keep the petition pending.

4. Accordingly, the Criminal Petition is disposed of with liberty to approach this Court, if any cause survives.

Miscellaneous Petitions, pending if any, shall stand closed.
