The present Criminal Petition is filed under Section 482 of Cr.P.C, seeking to quash the proceedings against the petitioner in F.I.R.No.977 of 2015 on the file of Station House Officer, KPHB Colony, Cyberabad at Rangareddy District.

2. On the last date of hearing, when the matter was taken up for hearing, there was no representation on behalf of petitioner; therefore, the matter was directed to be posted today under the caption 'for dismissal'.
