ORDER:

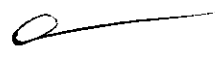
Learned counsel for the respondents on instructions of his client, has submitted that the entire amount has been paid and the cause in the Writ Petition does not survive for further adjudication.

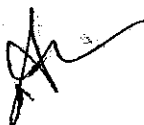

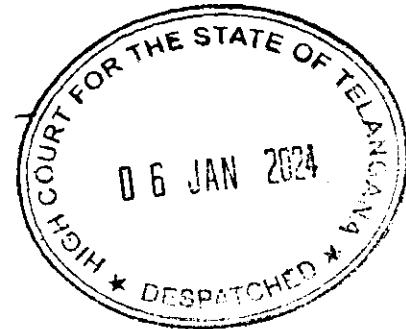
