ORDER:

This Criminal Petition is filed under Section 482 of the Code of Criminal Procedure, 1973 (for short 'Cr.P.C.') to quash the proceedings in STC No.17 of 2022 pending on the file of learned Judicial Magistrate of First Class-cum-Special Excise Court, Sangareddy District.

2. Heard learned counsel for the petitioners/A-1 and A-2 and learned Additional Public Prosecutor for the respondent-State. Perused the record.
