ORDER :

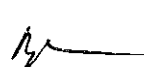

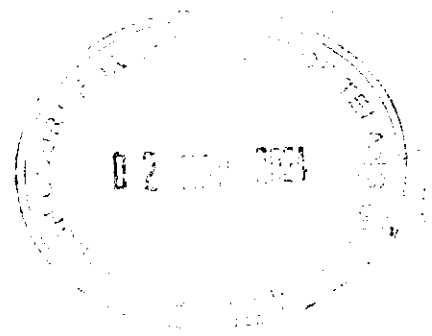
