Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, order or direction, more particularly one in the nature of Writ of Mandamus declaring the action of the Respondent No.3 in issuing the Memo No. B/11/2014 dated 06-01-2014 rejecting the representation dated 03-01-2014 of the petitioner for deletion of the Patta in Sy.No. 88 to an extent of 5566 Sq yards of Nizampet Village of Quthbullapur Mandal, Ranga Reddy District from the list of prohibited lands in File No. B/583/2012 dated 17-02-2012 communicated by the 3rd Respondent to 4th Respondent as illegal, arbitrary and against the principles of natural justice and violating the Article 14, 21 and 300-A of the Constitution of India and consequently direct the Respondent No. 3 to delete the Patta land in Sy.No. 88 to an extent of 5566 Sq yards of Nizampet of Quthbullapur Mandal, Ranga Reddy District from the list of prohibited lands in

File No. B/583/2012 dated 17-02-2012 communicated by the 3rd Respondent to 4th Respondent.

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the Respondent No. 3 to delete the Patta land in Sy.No. 88 to an extent of 5566 Sq yards of Nizampet of Quthbullapur Mandal, Ranga Reddy District from the list of prohibited lands in File No. B/583/2012 dated 17-02-2012 communicated by the 3rd Respondent to 4th Respondent pending disposal of the above writ petition.

ORDER:

1. This Writ Petition is filed seeking an order in the nature of *Writ of Mandamus* declaring the action of Respondent No.3 in issuing Memo No.B/11/2014, dated 06.01.2014, rejecting the representation of the petitioner dated 03.01.2014 for deletion of Patta in Sy.No.88, situated in an extent of 5566 Sq.yards of Nizampet Village, Quthbullapur Mandal, Ranga Reddy District, from the list of prohibited lands, as illegal and arbitrary and consequently to direct the Respondent No.3 to delete the said patta land from the list of prohibited lands.

2. Learned counsel for the petitioner states that the petitioner is not turning up. The said submission makes it clear that the petitioner is not interested to prosecute the Writ Petition.

3. Hence, the Writ Petition is dismissed due to non-prosecution. There shall be no order as to costs.

Miscellaneous petitions pending, if any, shall stand closed.
