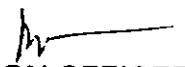
CCCA No.198 of 2003

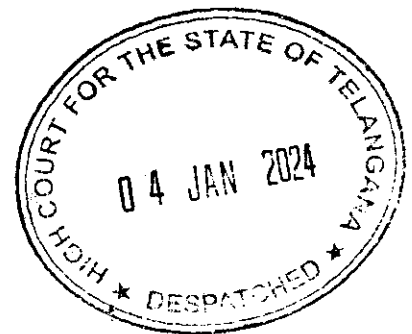
