ORDER:

This Criminal Petition is filed under Section 482 of the Code of Criminal Procedure, 1973 (for short 'Cr.P.C.') by the petitioner/accused to quash the proceedings in C.C.No.6 of 2016 on the file of the XXV Special Magistrate Court, Hyderabad at Erramanzil, registered for the offence against accused is punishable under Section 138 of Negotiable Instrument Act.

2. Heard Sri Pranank, learned counsel appearing for the petitioner and learned counsel for the respondent No.1-State and perused the record.

3. The case is of the year 2016, which is pending before the Special Magistrate Court at Erramanzil. Further, the Special Court's are now abolished. The learned counsel is not aware of the exact stage of the case in the trial Court. Hence,

this Court is not inclined to keep the Criminal Petition pending.

4. Accordingly, this Criminal Petition is disposed of granting liberty to the petitioner to approach this Court, if cause survives.

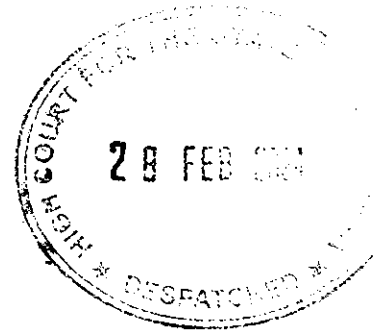
