Mr. A. Rama Krishna Reddy, learned counsel for the appellant on instruction seeks permission of the Court to withdraw the appeal.

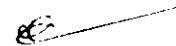
2. Permission is accorded.

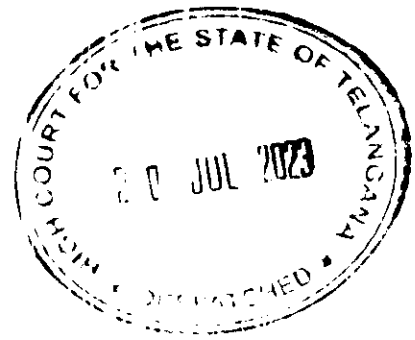
