WHEREAS the Petitioner above named through its Advocate Smt. VEDULA CHITRALEKHA presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ or order or direction, more particularly one in nature of Writ of Mandamus, to declare the action of the respondents in denying voting right to the workmen who completed continuous service of 6 months by the date of the election i.e., 05.01.2024, on the ground that the said period has to be reckoned with reference to the date of notification being 04.12.2023, as unreasonable, arbitrary and contrary to the Rules framed under the Industrial Disputes Act. 1947 and to issue a consequential direction to the respondents to permit those workmen who have completed 6 months continuous service by the date of election;

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Smt. VEDULA CHITRALEKHA, Advocate for the Petitioner, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.
