This Criminal Petition is filed under Section 482 of the Code of Criminal Procedure, 1973 (for short 'Cr.P.C.') by the petitioner-accused to direct the learned III Additional District and Sessions Judge, Ranga Reddy District at L.B. Nagar to issue summons to the concerned officials and call for the documents sought for in CrI.M.P.No.195 of 2016 in S.C.No.795 of 2015 on the file of III Additional District and Sessions Judge, Ranga Reddy District at L.B. Nagar.

2. On instructions, learned Additional Public Prosecutor would submit that the above Sessions Case was ended in conviction. Since the Sessions Case itself was ended in conviction, the prayer sought for in the present petition has become infructuous.
