This Criminal Petition is filed under Section 482 of the Code of Criminal Procedure, 1973 (for short 'Cr.P.C.') by the petitioner/accused No.2 to grant permanent exemption of appearance of petitioner/accused no.2 with an appropriate direction or order that the presence of the petitioner/accused No.2 at the time of trial may not be insisted upon the dispensing the petitioner in pursuance of Spl.S.C.No.27 of 2012 on the file of the Special Court for Trial of Offences under SC&ST (POA) Act-cum-VI Additional Metropolitan Sessions Judge, Secunderabad.

2. Heard learned Additional Public Prosecutor for the respondent-State and perused the record.

3. None appeared on behalf of the petitioner. The case is of the year 2012. No interim orders were passed by this
