Petition under Article 226 of the Constitution of India praying that in the  
circumstances stated in the affidavit filed therewith, the High Court may be  
pleased to issue a Writ, order or direction more particularly one in the nature of  
Writ of Mandamus by declaring the action of the Respondents in not processing  
the applications for release of electricity connections to the petitioner's building  
premises bearing Plot No. 401, H.No.3-296, admeasuring 275 sq yards in Sy.  
No.80, Situated at Adithya Nagar Colony, Hafeezpet Village, Serilingampally  
Mandal, Ranga Reddy District, now Medchal-Malkajgiri District as illegal,  
arbitrary, unjust and consequently direct the respondents to process applications  
for providing electricity connections and to release service connections with  
meters without any further delay.

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the 3rd Respondent to process applications for providing electricity connections and to release service connections with meters to the petitioner's building premises bearing Plot No. 401, H. No. 3-296, admeasuring 275 sq yards in Sy.No.80, Situated at Adithya Nagar Colony, Hafeezpet Village, Serilingampally Mandal, Ranga Reddy District, now Medchal- Malkajgiri District.

**WRIT PETITION No.25724 of 2023**

**ORDER:**

Heard Mr.L.Vishnu Prasad, learned counsel appearing on behalf of petitioner and of Sri R.Vinod Reddy, learned Standing Counsel for TSSPDCL, appearing on behalf of respondent Nos.1 to 3.

**PERUSED THE RECORD**

2. The limited relief sought for by the petitioner is a direction to the Respondents to release the power supply to the Petitioner's building premises bearing Plot No.401, H.No.3-296, admeasuring 275 sq.yards, in Sy.No.80, situated at Adithya Nagar Colony, Hafeezpet Village, Serilingampally Mandal, Ranga Reddy District, now Medchal-Malkajgiri District.

3. The grievance of the petitioner is that respondent Nos. 1 to 3 have not processed the application of the petitioner seeking power supply vide acknowledgment dated 08.08.2023 to petitioner's building premises bearing Plot No. 401, H.No.3-296, admeasuring 275 sq.yards, in Sy.No.80, situated at

Adithya Nagar Colony, Hafeezpet Village, Serilingampally Mandal, Ranga Reddy District, now Medchal-Malkajgiri District and further that no orders have been passed on petitioner's application vide acknowledgment dated 08.08.2023, till as on date.

**4.** When the matter is taken up for hearing, it is submitted by learned counsel for the petitioner that the issue involved in this writ petition is squarely covered by the order passed by this Court in W.P.No.20936 of 2023. The same is not disputed by Sri R.Vinod Reddy, learned Standing Counsel for TSSPDCL appearing on behalf of Respondent Nos. 1 to 3.

**5.** The learned Standing Counsel appearing for the respondents' authority, on instructions, has stated that since the application for providing electricity connection, dated 08.08.2023 of the petitioner is pending with the respondents, the respondents would consider the same and pass appropriate orders in accordance with law.

**6. Taking into consideration the facts and circumstances of the case and the submissions made by**

both the learned counsel on record and for the reasons alike in the above referred order passed by this Court in W.P.No.20936 of 2023 dated 04.08.2023, the Writ Petition is disposed of at the admission stage directing the respondent Nos.1 to 3 to consider and process the application vide acknowledgment dated 08.08.2023 made by the petitioner for providing electricity connection to the petitioner's building premises bearing Plot No.401, H.No.3-296, admeasuring 275 sq.yards, in Sy.No.80, situated at Adithya Nagar Colony, Hafeezpet Village, Serilingampally Mandal, Ranga Reddy District, now Medchal-Malkajgiri District, in accordance to law, within a period of two(02) weeks from the date of receipt of the copy of this order and pass appropriate orders, duly communicating the decision to the petitioner.

7. With these observations, the Writ petition is disposed of. However, there shall be no order as to costs.

Miscellaneous petitions, if any, pending shall stand closed.
